Term Length, Board Category Re-Evaluations & Seattle Rotation

- * Customer categories are to be re-evaluated every 5 years. The categories were most recently recomposed on January 1, 2022 and will next be recomposed on January 1, 2027.
- * Determination of Categories will be based on ERU's. The formula used for 2022: annual purchases from 2016-2020 (in ccf) divided by the average annual ERU for the Seattle regional system (5.9 ccf per month x 12 = 70.8 ERU).
- ** Utility Representative This is the official representative to the Operating Board. It is the primary point of contact, participates in caucuses and is eligible for nomination to the Operating Board.
- *** Seattle and the 7th independent member are considered separate categories.
- *** Operating Board Member Terms = 4 years
- *** One Seattle member term expires at the same time as each of the Category member term expires.
