Term Length, Board Category Re-Evaluations & Seattle Rotation

- Customer categories are to be recomposed January 1, 2012 **
- Determination of Categories will be based on ERU's. The formula used: Annual purchases from SPU in 2010 (in ccf) divided by the average annual ERU for the Seattle regional system (6.8 ccf per month x 12 = 81.6, rounded to 82)**
- Utility Representative Official representative to Operating Board, primary point of contact, eligible for nomination to OB and participates in caucuses***
- Seattle and the 7th independent member are considered separate categories***
- Operating Board Member Terms = 4 years*
- One Seattle member term expires at the same time as each of the Category member term expires*
- Categories are to be re-evaluated every 5 years beginning January 1, 2012***

^{*} Full/Partial/Block Wholesale contracts Exhibit IV and OB By-Laws Section 5 – Terms of each Board position shall commence on January 1 and shall be for four (4) years and each Board position shall be staggered such that no more than two positions are renewed in any single year.
