## Term Length, Board Category Re-Evaluations & Seattle Rotation

- Customer categories are to be recomposed January 1, 2012 \*\*
- Determination of Categories will be based on ERU's. The formula used: Annual purchases from SPU in 2010 (in ccf) divided by the average annual ERU for the Seattle regional system (6.8 ccf per month x 12 = 81.6, rounded to 82)\*\*
- Utility Representative Official representative to Operating Board, primary point of contact, eligible for nomination to OB and participates in caucuses\*\*\*
- Seattle and the 7<sup>th</sup> independent member are considered separate categories\*\*\*
- Operating Board Member Terms = 4 years\*
- One Seattle member term expires at the same time as each of the Category member term expires\*
- Categories are to be re-evaluated every 5 years beginning January 1, 2012\*\*\*
