### <u>Annual Accounting of Retail Connections</u>

Regina Carpenter, SPU Sr. Economist gave the results of the 2012 annual accounting of retail connections with a reminder that FC's need to be paid after a meter has been removed for 2 years or more and is then re-established.

### • Facility Charge

Regina Carpenter, SPU Sr. Economist gave a power point presentation on New Supply Capital Cost Recovery (aka: Rates vs. FCs). The presentation included background of why the OB is discussing FCs again (decide rates vs. FCs for 2014+), relevant contract definitions, authorities and calculations, and the details of the most recent (2010) rate vs. FC decision. Ray Hoffman, OB member motioned and Matt Everett, Chair seconded to have Regina come back at the May 2013 meeting with an analysis of updating FC's

going forward using the methodology approved in 2010. Also, for the OB to consider agreeing to the next review period on FC's be in 5 years instead of 3 years.
