2014 Wholesale Financial True-up Report

SPU's Regina Carpenter and Moss Adams Amy Sutherland and Alan Hartmann presented the results of the 2014 Wholesale Statements and Independent Accountant's Report (True-up).

 Byron Murgatroyd, Small Category OB member and Ken Howe, Woodinville Utility Representative made a request to understand how the multiplier is used and applied to the O & M.

- Ron Speer, Large category OB member motioned to bring the topic back after a smaller group takes the time to go over how the multiplier is applied to the O & M and then come back to the OB for a follow up discussion. Ray Hoffman, Seattle OB member 2nd the motion and the Board approved it 6-0.

Water Supply Update

Alex Chen, Water Planning and Program Management Director gave a power point presentation on the current and future outlook of this year's water supply conditions. Mr. Chen shared that we are still in "good" condition but that we are experiencing historic low inflows and will be meeting with the Mayor the following week to discuss moving to "fair" condition. Some discussion occurred regarding when SPU might activate the Water Shortage Contingency Plan with a discussion to possibly meet for the August 6th, 2015 OB meeting.

 A Board member motioned to meet for an August meeting if SPU determines it is important to meet due to ongoing weather conditions the motion was seconded and the Board agreed 6-0.

Watershed Wildland Fire Team

Suzanne Flagor, Watershed Division Director gave a power point presentation on SPU's fire protection/response plans in the event of wildfires in the watershed. Ms. Flagor began the presentation with some historical content to the acquiring of the land in the watershed. She mentioned SPU has gone over 15 years without lighting strikes (until this year) within the watershed but when one occurs SPU will go out and investigate the area when one strikes. Lighting and recreational use are the two most likely reasons for a forest fires. The wildland fire team has had years of experience through tabletop exercises and the Utility when possible will sends the teams out for real life fire training to assist to assist other fire teams when wild fires have occurred. No questions followed the presentation.
