#### 3. New Business

### **3a) Fall Water Supply Updates**

Elizabeth Garcia, Seattle Public Utilities (SPU) Water Resources Planner, provided a PowerPoint presentation on the water supply year and current supply situation. Highlights included: Ecology declaring drought "advisories" or "emergencies" across the state ("advisory" in our area); the 2023 water year for the Seattle regional system being drier, having lower reservoir storage, and having higher demand compared to average years; and SPU activating the Water Shortage Contingency Plan (WSCP) in September. Current climate predictions are for the return of El Nino, which generally means warmer and drier conditions. Currently, SPU reservoirs are rising but not quite back to normal conditions for this time of year. The WSCP will remain in effect until the supply is closer to normal for this time of year. There was a question and a discussion about what supply could look like next year.

### 3b) SPU Wildfire Risk Management Strategy

SPU's Julia Munger, Watershed Natural Resources Manager, and Chris Hilton, Utility Resilience Advisor, provided a PowerPoint presentation on SPU's Wildfire Risk Management Strategy. The presentation covered the goals and tactics of the strategy, a wildfire risk analysis currently underway, and lessons learned from recent PNW fires.

### 3c) Cascade Contract Negotiations Update

Alex Chen, SPU Water LOB Deputy Director, and Andrew Lee, SPU GM/CEO, shared information on the status of the contract negotiations with Cascade Water Alliance. The presentation included options SPU

is considering, including associated risks and benefits. There was a robust discussion after the presentation.

- Water Consumption from Watersheds vs. Rate Studies: Actual consumption to date is 4% higher than the 2020 Rate Study projection and 3% higher than this time last year.
