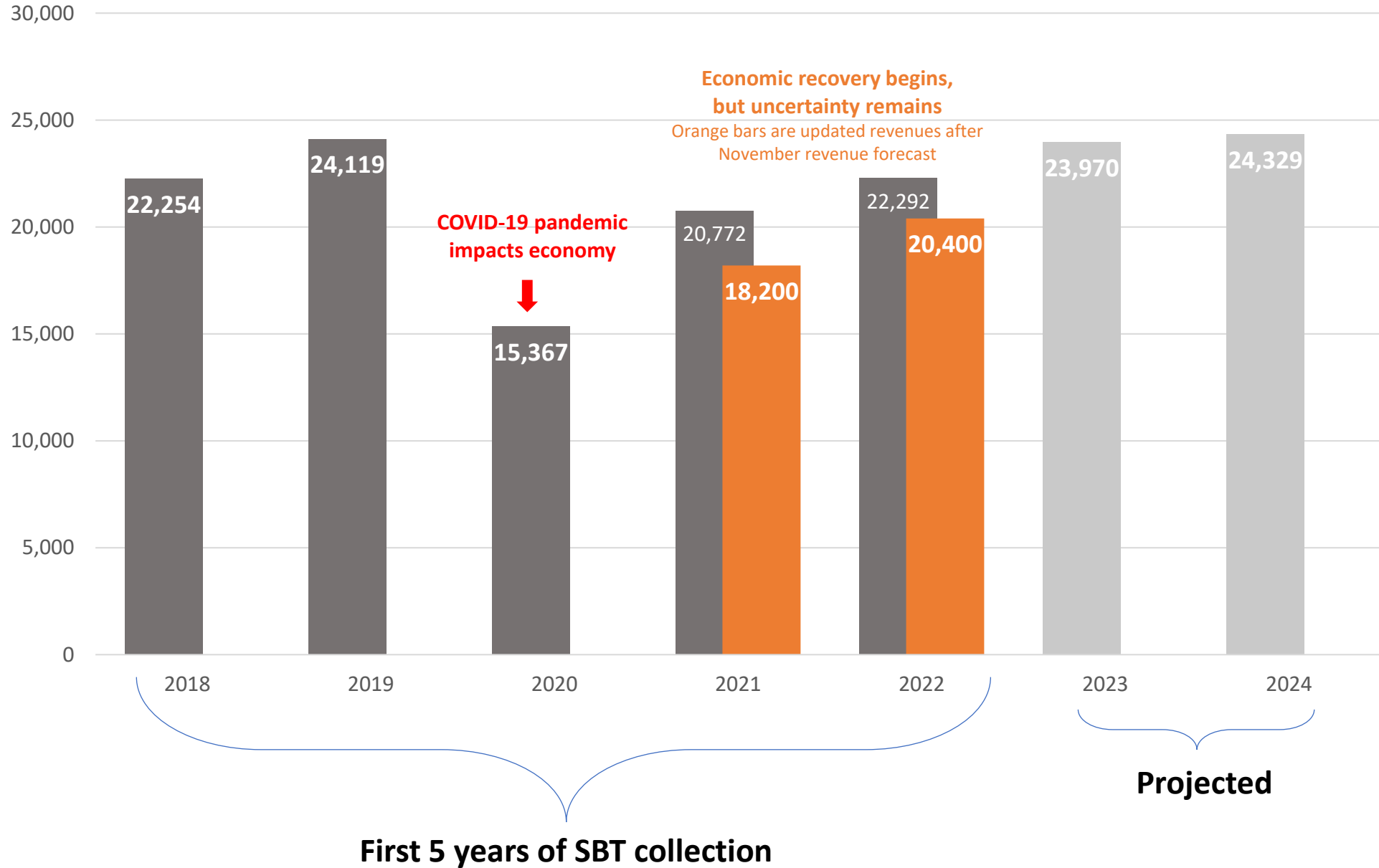

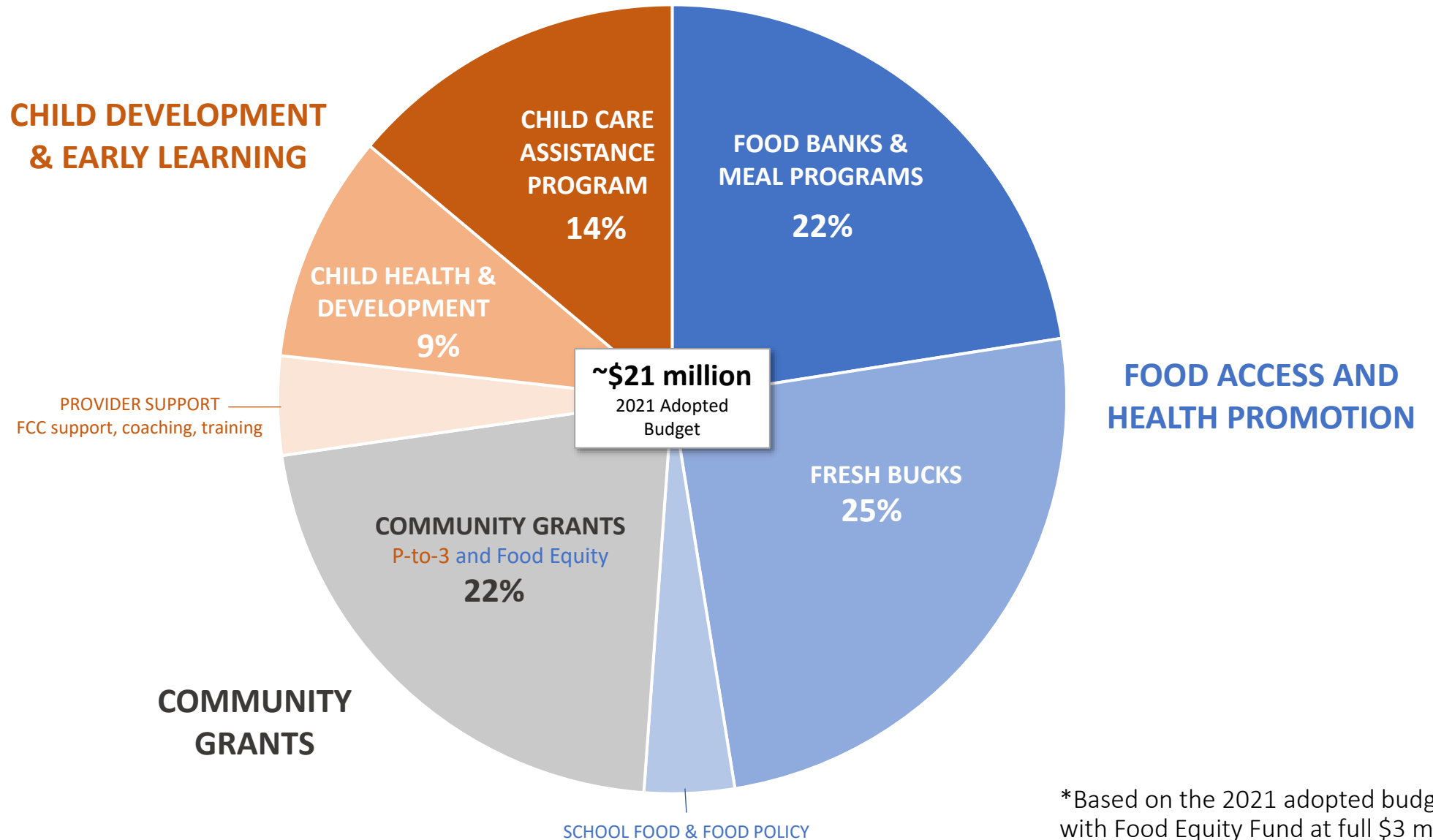

2021 Adopted Budget*

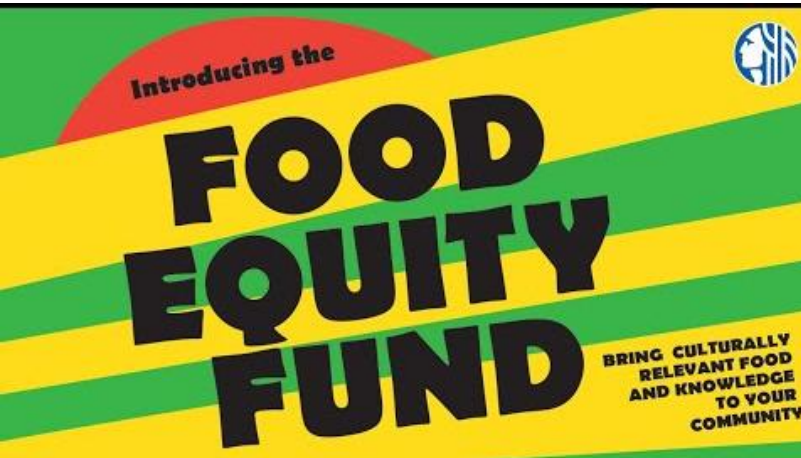

**The total 2021 adopted budget of ongoing food and early learning/child development funds is around \$21 million. The Food Equity Fund is included at full \$3 million allocation, instead of original \$1.5 million that was in 2021 adopted budget. Other expenses not included here are the reserve fund, SBT evaluation, and some administrative costs.*

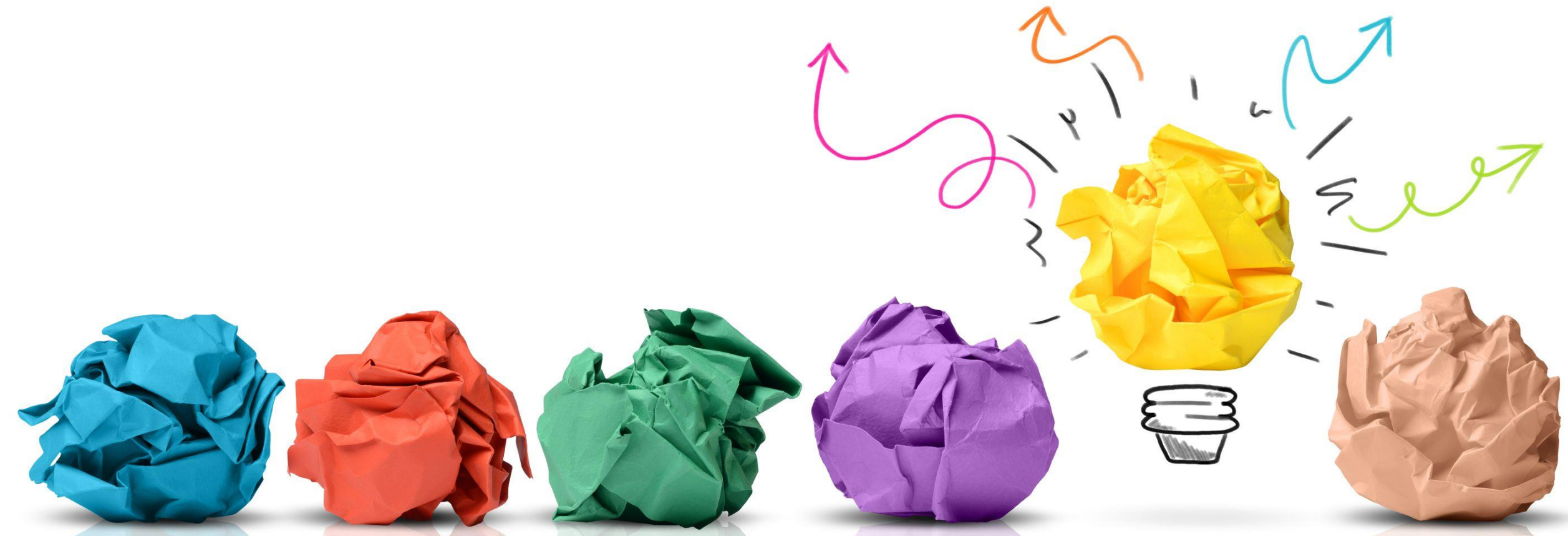

Green New Deal Resolution [31895](#)

Section 8. The City recognizes the importance of expanding access to healthy, affordable, locally produced, and culturally relevant foods to improve community health and reduce reliance on mass-produced, highly-processed foods that contribute to climate pollution and negatively impact public health, and will continue to:

1. Promote community food production;
2. Encourage the consumption of more plant-based foods and locally-produced foods;
3. Explore potential locations on public property where urban agriculture and gardening may be possible; and
4. Invest Sweetened Beverage Tax proceeds to increase access to healthy foods for residents in the food security gap
