AN ORDINANCE relating to historic preservation, imposing controls upon the Beacon Hill First Baptist Church, a landmark designated by the Landmarks Preservation Board under Chapter 25.12 of the Seattle Municipal Code (Ordinance 106348).

WHEREAS, the Landmarks Ordinance, Chapter 25.12 of the Seattle Municipal Code, establishes a procedure for the designation and preservation of structures and areas having historical, cultural, architectural, engineering or geographic importance; and

WHEREAS, the Landmarks Preservation Board after a public hearing on October 15, 1980, voted to approve the nomination of the Beacon Hill First Baptist Church at 1607 South Forest Street in Seattle as a landmark under Code Chapter 25.12; and

WHEREAS, after a public hearing on November 19, 1980, the Board voted to approve the designation of the Beacon Hill First Baptist Church as a landmark under Code Chapter 25.12; and

WHEREAS, on January 21, 1981, the Board approved controls and incentives for the designated property; and

WHEREAS, the Board recommends to the City Council approval of controls and incentives; Now, Therefore,

BE IT ORDAINED BY THE CITY OF SEATTLE AS FOLLOWS:

Section 1. That the designation by the Landmarks Preservation Board of the Beacon Hill First Baptist Church, more particularly described as: Lot 4, Block 53, T. Hanford's Addition to South Seattle, as a landmark based upon satisfaction of the following criteria of Code Section 25.12.350:

(1) It embodies the distinctive visible characteristics of an architectural style, or period, or of a method of construction; and

(2) It is an outstanding work of a designer or builder; is hereby acknowledged.

Section 2. The following controls upon alteration of the landmark are hereby imposed:

A Certificate of Approval must be obtained or the time for denying a Certificate of Approval must have expired

1 before the owner may make alterations to: 1) the
2 entire exterior of the original structure; and 2) the
3 interior of the sanctuary; provided that, nothing
4 herein shall prevent any changes in such features where
5 such changes are necessitated by changes in the liturgy,
6 it being understood that the owner is the exclusive
7 authority on liturgy and is the decisive party in
8 determining what architectural changes are appropriate
9 to the liturgy. Any in-kind maintenance and repair for
10 the above-noted features shall be excluded from the
11 above controls.

12 Section 3. The following incentives are hereby noted
13 as potentially available to the owner although the listing

15 As a part of Code Section 24.74.020 - Special Exceptions -

20 Section 4. Enforcement of this Ordinance and penalties
21 for its violation shall be as provided in Section 25.12.910

23 Section 5. The City Clerk is hereby directed to record

25 Elections, deliver two copies to the City Historic Preservation

Beacon Hill First Baptist Church - 1607 South Forest Street

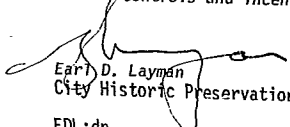
To assure the preservation of the specified features and characteristics of the above named Seattle Landmark, a Certificate of Approval issued by the City of Seattle's Landmarks Preservation Board pursuant to City Ordinance #106348 must be obtained, or the time for denying a Certificate of Approval application must have expired, before the owner may make major alterations or significant changes which affect:

1. the entire exterior of the original structure;
2. the interior of the sanctuary;
3. provided that, nothing herein shall prevent any changes in such features where such changes are necessitated by changes in the liturgy, it being understood that the owner is the exclusive authority on liturgy and is the decisive party in determining what architectural changes are appropriate to the liturgy;
4. provided that, all in-kind maintenance and repair of the above noted features shall be excluded from the Certificate of Approval requirement.

As part of Section 28.2 - SPECIAL EXCEPTIONS - of the City zoning Code, certain incentives are noted as potentially available, on an application basis, to the owners.

REPORT ON DESIGNATION

Name of Property: Beacon Hill First Baptist Church, 1607 So. Forrest Street.

Legal Description: Hanford's Block 53 Lot 4

At its meeting held November 19, 1980 the City of Seattle's Landmarks Preservation Board voted to approve Landmark Designation of the Beacon Hill First Baptist Church based upon satisfaction of the following Landmark criteria, City Ordinance 106348:

Section 3.01 (4) It embodies the distinctive visible characteristics of an architectural style, or period, or of a method of construction;

Although Ellsworth Storey designed three churches in Seattle (Epiphany Episcopal Chapel, and University Unitarian Church) Beacon Hill First Baptist is essentially non-stylistic and is a more forthright expression of the function "Protestantism" and is much more akin qualities and details of Storey's residential architecture in the city. These characteristics speak clearly of the authorship, e.g., hovering, low pitched roofs, hovering space in the sanctuary, use of stained shingle course and white trim (original skin and detailing) and general character. Although one of the pair of external stair-and-porch approaches has been eliminated by a later addition, the building has been sheathed in asphalt "shakes" and spray painted white, and some detail elements have been lost or removed, none of these changes is irreversible since the basic fabric and form are intact.

Section 3.01 (5) It is an outstanding work of a designer or builder;

In its original condition this church would rank among Ellsworth Storey's best works, and relates well to his body of residential work.

Features or characteristics identified for preservation include:

the exterior of the entire structure, and the interior of the sanctuary.

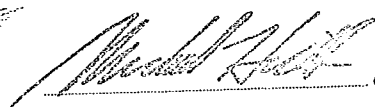
