DAVID ARNESEN

Professor Arnesen has been a faculty member at Seattle University for more than 30 years. He is the former chair of the Department of Management and acting Dean of the Albers School of Business & Economics (2000-01). I was a member of the CAC during the development of the last MIMP and part of a minority whose appeal to the City Council resulted in a denial of the University's proposal to expand its boundaries to the east side of 12th Avenue to include the Photographic Center site.

Mr. Zosel is most concerned with encouraging future development of the University on 12th Avenue be consistent with the spirit of the pedestrian overlay. He is interested in seeing that the University does not displace existing or potential commercial uses on 12th Avenue, minimize its impacts on adjacent residences and move more commuters out of Single Occupancy Vehicles to transit.
