OIRA provides technical assistance to every City department to ensure their availability and capacity to serve all residents regardless of the language they speak. Our focus includes simplifying language access processes, providing interpretation services, translating important materials, and conducting outreach in languages other than English.

NCC supports local service providers to offer naturalization assistance to eligible Seattle residents through citizenship workshops, collaborative partnerships, policy advocacy, and the training of legal advocates.

### New Citizen Program (NCP)

NCP funds a consortium of local community-based organizations offering assistance with naturalization applications to low-income individuals who have high barriers to obtaining citizenship. Organizations also provide citizenship classes, tutoring, practice interviews, help preparing exam waivers for disabled individuals, and case management throughout the entire process. Services available in a wide range of languages.

### Ready to Work (RTW)

RTW is a partnership with organizations offering English for Speakers of Other Languages (ESOL) classes, job training, and case management in three locations to better serve residents facing immense barriers to learning English and gaining employment.
