Park District Frequently Asked Questions Covered:

- The Park District boundaries are the same as the city of Seattle boundaries.
- No revenue from the Park District will be collected until 2016. 2015 is the gap or ramp up year in funding
- Gap year funding will be focused on hiring staff to support the Seattle Park District, start programs and establish performance measures.
- Seattle City Council is the charged with of governance Seattle Park District.
- The Inter-local agreement layouts out how Seattle Parks and Recreation will work with the funding
 provided through the park district, how we engage with the public and accountability and
 responsibilities are. It also outlines how the District Oversight Committee supports with Parks, Council
 and the Mayor in the administration of Park District funds.
- The Park District Oversight Committee is charged with helping Seattle Parks and Recreation ensure the Park District is administered equitably, transparently, engages the public and delivers the outputs outlined in the 6-year spending plan.

- 4. Committee will adopt Robert's Rules of Order as their discussion facilitation and group decision-making guidelines.
- 5. Committee will adopt Job descriptions that clarify their function.
