The exam application filing dates will be **January 3-16, 2024**. The written examination for Fire Captain will be held on **Saturday, March 23, 2024**, at a location to be determined.

NOTE: New reference material issued after December 22, 2023, will NOT be included on the written examination portion of the process.

Candidates who pass the written examination will be scheduled for the oral board portion of the examination (assessment center), tentatively scheduled for **May 20-24, 2024**. Candidates may need to attend more than one day during this period.

Please see the “Outline of the Command Job” for the general scope of the promotional examination. The assessment center examination exercises will be based on the 1) skills and abilities identified by the job analysis as critical for successful job performance as a Fire Captain, 2) information from the Promotion Development Committee who serve as subject matter experts, and 3) reading materials in the bibliography. Therefore, the assessment center topics are not limited to materials on the bibliography.

All examination dates, times, and locations are tentative as exam administration may be changed due to COVID-19 public health guidelines.
